## II. Committee Updates

- a. Peer Review
  - i. December 2<sup>nd</sup> deadline for submission of the 2015-2016 annual assessment reports. If department programs have not been submitted their reports yet, encourage them do so as soon as possible.
  - ii. Peer review teams are scheduled for training the week of December 12 and will assigned programs to review.
  - iii. The rubric in the document repository will be updated to exclude date specific information.

# b. Professional Development

- i. Results of the Symposium survey to be shared after the subcommittee has met to review the feedback. Overall, the feedback was very positive.
- c. Academic Program Review
  - i. 16-17 Programs undergoing review (10 areas) include:
    - 1. Spring: American Studies, Chemistry, English, Biomedical Sciences, Clinical and Translational Sciences, Pharmacology, MD.
    - 2. Medical Anthropology and Social Work are ready for review. Medical Microbiology and Immunology is finishing up and will be submitted soon for review.
  - ii. Recommended to create an Academic Program Annual Report to be shared with university leadership and faculty academic councils, with emphasis on how the programs have improved.

- d. Assessment Resource Integration
  - i. Pilot rubrics in additional courses to include the Magis Core courses.
  - ii. Spring will launch a broader request for training for others on campus.
- e. Policy, Strategy, and HLC updates
  - i. Joint and Dual Degree Policy was reviewed. It is still in the approval process and will most likely be approved.
  - ii. The processes related the Creighton Bulletin/Catalog on the website need to be reviewed to include transition of new programs/courses added mid-cycle.
  - iii. HLC proposal, submitted by Tracy Chapman, was accepted, "Establishing an Academic Planning Structure and Process" at the HLC Conference in late March. Jess Graner and Mary Ann Danielson will be presenting with Chapman.
