## Opening Reflection

- I. Announcements
  - a. Assessment conferences:

- a. Peer Review
  - i. Teams have been assigned. The review process is ongoing.

#### b. Professional Development

- i. Assessment Symposium Fall 2017 has been scheduled for Friday, Nov. 3; 8-11 in the Skutt Ballroom. The focus of the symposium will include collaborative efforts between students and faculty. Several AEA grants have focused on the topic as well. Recommended speaker: Katie Huggett.
- ii. Spring 2017 Programming Ideas and Discussion
  Three different areas of potential programming were discussed: 1) Teaching
  Assessment to address where programs are "stuck," provide artifacts of measures,
  have dean's identify "best practices" from 2013-2015 on student learning, student
  learning and assessment. 2) Cultural Differences of Assessment by train-the-trainer,
  and 3) Program Review Process Overview

# c. Academic Program Review

- i. 16-17 Programs undergoing review (11 areas) include:
  - 1. Reviews completed: Medical Anthropology, Social Work, Microbiology and Immunology.
  - 2. Spring: American Studies, Chemistry, English, Biomedical Sciences, Clinical and Translational Sciences, Pharmacology, MD, and Clinical Anatomy. The review cycles for the programs should be completed by March.
  - 3. View updated academic program review calendars for 2016-2023.

- d. Assessment Resource Integration
  - i. Hiring for open design position; once hired, the process can be initiated.
- e. Policy, Strategy, and HLC updates
  - i. HLC Updates: The Creighton student opinion survey was emailed to students, encouraging them to provide feedback on their experience at Creighton. The survey is open Feb. 6-15. The HLC team for on-site visit is being formed. The committee is waiting to hear from HLC on those details.
