# Insurance Coverage for the Health and Human Services SWK 369

## I. Course Description

Course is intended to survey the range of public and private insurance opportunities specifically focusing on insurance for the poor. Fmphasis is on implementation of insurance and policy guidelines, eligibility requirements, and application processes. The course is intended for health and human service professionals including social workers, nurses, and other mental health professionals.

- 1. Understand the availability of insurance programs--private and public.
- 2. Understand the difference between mental health and physical health insurance coverage.
- 3. Understand and use the application for client seeking health coverage.

5. Advocate for client rights relative to coverage.
