# For Faculty: *Magis! Investigatio* Research Award (MIRA)

## Amount of award:

- Up to \$5,000

## Types of Requests to be Funded:

- Equipment
- Supplies
- Research-related travel
- Payment of undergraduate research assistants
- Open access publication charges

## Types of Requests NOT Funded:

- Faculty salary or conference travel

# For Faculty: *Magis! Investigatio* Research Award (MIRA)

## Eligibility:

- Full-time faculty holding a Teaching-Research, Clinical-Educator, or Resident Faculty appointment (Research, Adjunct, Special, Visiting, Affiliate or Contributed-Service Faculty are not eligible).

## Award Cycle:

- **Fall** (due October, funding November Year 1-June 30<sup>th</sup> Year 2)
- **Spring** (due March, funding May 1<sup>st</sup> Year 1 –June 30<sup>th</sup>, Year 2)

## Proposal Components:

1. Abstract
2. Rationale
3. Description
4. Undergraduate Student Training and Mentoring Plan
5. Evaluation Plan
6. Bibliography
7. Budget and Budget Justification
8. Biosketch

= 3 pages, single-spaced (max)

# For Faculty: Summer Faculty Research Fellowship (SFRF)

## Amount of award:

- Up to \$10,000

## Types of Requests to be Funded:

- Equipment
- Supplies
- Research-related travel
- Payment of undergraduate research assistants
- Faculty summer salary

## Types of Requests NOT Funded:

- Conference travel

## Eligibility:

- Full-time tenure-track faculty of the College of Arts and Sciences, the Heider College of Business, College of Nursing, and the School of Law

# For Faculty: Summer Faculty Research Fellowship (SFRF)

## Award Cycle:

- **Fall** (due November, funding May 1 Year 1 –June 30<sup>th</sup>, Year 2)

## **Proposal Components:**

1. Abstract
2. Statement of Problem/Purpose
3. Significance
4. Summary of Pertinent Literature
5. Research Questions/Hypotheses
6. Design and Methods

= 6 pages, single-spaced (max)

7. Bibliography
8. Budget and Budget Justification
9. Biosketch

## For Faculty: Open Access Fees

- Open Access/Publication fees can be difficult to time for a particular funding call.
  - We do accept off-cycle publication fee requests (maximum of \$500).
  - Only available to those without external funding mechanisms that include funding for publication charges

32 awarded in summer 2022

\$4000 student stipend, \$500 supply budget

\$1500 faculty stipend

## **Student travel support to present at regional/national/international conferences**

\$500 travel funding per student

\*\* Honors & Dean's Fellows Program students receive additional travel/research support

## **Undergraduate Research Student Ambassador Program (junior-senior)**

~10 Student Ambassadors currently

\$500 support for supplies, books, travel annually

# Haddix Program Purpose

The Dr. George F. Haddix President's Faculty Research Fund was established to support and enhance the research and scholarly work of full-time faculty at Creighton University. Faculty are encouraged to engage students in their research and scholarship programs.

# Haddix Funding Categories

Three categories of research/scholarly proposals will be considered for support:

- New investigators or initiation of a research project that represents a new direction for established faculty with the intent to build on this work and/or seek external funding. Can request up to \$5,000.
- Scholarship of teaching/learning and/or mission-based projects. Can request up to \$5,000.
- Interdisciplinary team-focused projects that cross two or more Creighton University schools or colleges or two or more disciplines. Can request up to \$15,000.

# Haddix Eligibility

To be eligible for a Haddix award, PIs must be full-time faculty holding one of the following appointments:

- Teaching-Research
- Clinician-Educator
- Resident Assistant Professors/Research Assistant Professors

Emeritus, Adjunct, Special, Visiting, Affiliate, or Contributed-Service Faculty, Residents, and Fellows are not eligible to be PIs.

# Haddix Eligibility

Priority will be given to:

- Faculty who have never received a Haddix award
- Applications that include a well-defined student research component
- Applications that involve multidisciplinary teams with a clear plan to develop future extramural applications

# Haddix: Submission

- Proposals are routed through InfoEd for University approvals.
- Application should be uploaded as one PDF document to the Attachments tab.
- InfoEd instructions are available at <https://www.creighton.edu/researchservices/grants/infoed/>.
- Applications are considered submitted once they have been put into routing for University approvals.

# Haddix Application Preparation

The following documents are required in this order:

1. Proposal Narrative (6-page limit)
2. Timeline of project
3. Budget (form available on Sponsored Programs website)
4. Budget justification
5. Biographical sketches for all key personnel (5-page limit)
6. Bibliography/references cited
7. Description of the results of past Haddix funding (if applicable) (1-page limit)
8. Letters of support (OPTIONAL, two 1-page letters maximum)

**No other documents or appendices are allowed.**

# Haddix: Proposal Narrative

- 6-page limit—use your pages!
- Headers (in this order):
  - Abstract or Executive Summary (1/2-page limit)
  - Rationale: What's the impact?
  - Description:
    - Project aims/goals, plan, and methods.
    - Include description of use of animals or human subjects, if applicable.
    - What is the expected outcome of the project (e.g., future grant submissions, book, article, curriculum revision or addition)?
  - Evaluation Plan: How will you measure whether your project was successful?



# Haddix Budget: Allowable Expenses

Grant support will be considered for a broad range of requests, including the following:

- Summer salary **and associated fringe benefit costs** (only for faculty with 9-, 10-, and 11-month appointments)
- Research assistants and technical support **and associated fringe benefit costs**
- Student wages
- Equipment (matching funds required if proposal is for equipment only)
- Travel
- Supplies
- Publication costs

# Haddix Budget: Unallowable Expenses

- Academic year salary
- Space
- Renovations
- Repairs
- Indirect costs
- External collaborator costs



# Haddix: Keep in Mind...

- Summer salary **must** have fringe benefits included.
- Course release requests must have written approval of the department chair and dean.
- All activities and work charged to the grant must take place within the grant period.
- If students are working on the project, include compensation for their time.
- If your project involves animals or human subjects, all university procedures must be followed.
  - Approval for animal or human subject protocols must be received before funds can be released.

# Haddix: Tips for a Successful Submission

- You have six pages—use them all! If you submit a 2-3 page narrative, there probably isn't enough detail.
- Peer review: Ask someone in your field whom you trust to read your proposal.
- Lay review: Ask someone (hey, we have an editor on staff in Sponsored Programs!) to read your proposal for flow, clarity, compliance with guidelines, etc.
- Proofread, proofread, proofread (or have someone do it for you).

# Haddix: Audience

- Reviewers are from all across the Creighton campus.
- Reviewers may not (and probably won't) be experts in your field.
- Write your proposal in language understandable to a non-expert audience.

# Haddix: Deadlines

- All grants are due by 4:30 PM on Friday, December 2, 2022.
- All required documents must be uploaded to InfoEd in one PDF file.
- Don't submit on the deadline day!
- Plan to start your route five business days in advance—we need to review your application package and leave enough time to route for approvals.

# Haddix: Working with Sponsored Programs

- We can answer any questions and clarify the guidelines.
- Barb Bittner can review and edit the narrative sections of your proposal upon request, as long as it is received at least two weeks before the deadline.
- When we receive the application via InfoEd during routing, we will review it for completeness and compliance with the guidelines.

# Haddix: Working with Sponsored Programs

- The earlier you route your application, the more help we can give.
- If you route your application on the deadline day, we won't have time to ask for required changes.
- If that happens, we can't guarantee a successful submission.

# Haddix: Award Requirements

- Final report due at the end of the project
- Presentation at University Research Day

# CFE Faculty Development Grants

## **Focus of Grant:**

to provide seed money for work in early stages of developing a Scholarship of Teaching and Learning (SoTL) project, and/or designing faculty development initiatives to achieve advancements in student learning.

**Range of funds:** \$500-\$2000

# Scholarship of Teaching & Learning (SoTL)

Faculty conducting systematic inquiry

- into student learning; and
- going public with the results.

## Examples:

- Study of the impact of interdisciplinary, service-learning, experiential, digital, etc., teaching strategies on student learning.
- Design faculty development initiatives to achieve advancements in student learning.
- Research support for the analysis of student learning outcome data (e.g., course-, program- or college/school-level assessment), particularly as it is used to modify teaching and learning activities.
- Development of rubrics to assess student learning in or across a variety of teaching sites (i.e., classroom, clinic, service-learning site, on-line instruction).
- Examining the effect of COVID-19 experiences on teaching & learning.

## CFE Development Grant Proposals

### Criteria for Selection:

- Ability to lead to significant, positive changes in student learning;
- Likelihood that the project will be successfully completed;
- Likelihood that the project will advance the department's or the unit's pedagogy, curricular or assessment efforts; and
- Sustainability of project and/or results beyond the funding period.

## CFE Development Grant Proposals: Requirements

- Provide a brief progress report of project, detailing products and actions resulting from the work. Due: **May 18, 2023**.
- Publicly share the product in an appropriate venue. Unless another venue is identified, an on-campus research presentation/poster session, will be required and scheduled for **spring 2024**.
- Provide a final report at time of presentation, by **April 25, 2024**.

# Kingfisher Curriculum Development Grants

## 2022-2023 Call:

- Engage students with interdisciplinary issues at the core of our initiatives – **any** of the three!
- Up to ten grants (stipends) of \$1000 available.
- Any credit-bearing course taught by a Creighton faculty member is eligible (adjunct, tenure-track, etc.).
- Integration into existing courses is encouraged.
- Due **Dec. 1, 2022**, or **May 15, 2023**
  - Final report due after semester taught
