2012 INCOME INFORMATION FOR FEDERAL INCOME TAX FILERS

As a result of recent changes in federal regulations, federal tax returns are no longer considered to be acceptable documentation of income. The IRS tax return transcript is now required. When you completed the FAFSA, you (and your parent(s), if dependent) had the option to select the IRS Data Retrieval process. This allows the IRS to transfer your tax return information directly to your FAFSA.

- If you (and your parent(s), if dependent) selected the IRS Data Retrieval process, and were notified that the transmission was successful, you do not need to submit a copy of your tax return transcript. Be sure to submit copies of all 2012 W-2s to the Financial Aid Office.
- If you (and your parent(s), if dependent) did not select the IRS Data Retrieval process, or the transmission was not successful, you will need to submit a copy of your (and your parents, if dependent) tax return transcript (go to the Verification menu item at www.creighton.edu/financialaid for instructions) and copies of all W-2s to the Financial Aid Office.
