- I. Introductions
 - a. The board welcomed some new individuals to the group including Sarah Sjolie from Alegent Creighton Health, Monica Rogers from the Health Sciences Library, and Kristie Briggs from Business.

- II. Current Events:
 - a. Dr. Dickel gave his initial thoughts on a new book “College Girl” written by Laura Gray-Rosendale about recovery from domestic violence. Dr. Dickel mentioned the writer is creative and it is taking a while to really get into the heart of the book but he will give another review at the next meeting.

- III. Harassment, Discrimination, and Prevention Education: A brief power point presentation was delivered by Allison Taylor as a preview of information presented at new student, staff, and faculty orientation.
 - a. Information on prevention education and resources is mandatory per federal law
 - b. Feedback on presentation
 - i. Group feedback consisted of the following suggestions:
 1. Include definitions of terms such as harassment and discrimination and provide examples for the audience
 2. Clarify sexual misconduct as a term
 3. Further explanation needed on mandatory reporters
 - a. Just to supervisor, or required to report further?
 - b. Clarifying difference between mandatory reporting on child abuse and on this policy
 - c. What needs to be reported? On/off campus incidents
 4. Explanation of reporting form and information as to what happens after report is received
 - a. Which fields are required on the online form
 5. Resources- Add Office of Civil Rights to the list
 - ii. Importance of mandatory reporters
 - i. Knowledge and understanding of policies
 - ii. Opportunities to be more involved- advocates and process navigators
 1. Office of Equity and Inclusion is working on developing a pool of individuals who could serve in this capacity. They would work with complainants and respondents in the investigation process. Contact Allison for more information.
