University College Deans Merit Award

Tuition assistance is designed to help adult students manage the cost of tuition at Creighton University. The amount of assistance varies from \$100 to \$700 per semester. Funding is limited, therefore, there is no guarantee that all applicants will receive aid. You must complete this form each semester for aid consideration.

Application Deadlines: December 1 for Spring semester
 May 1 for Summer semester
 August 1 for Fall semester

Qualifications:

1. Be accepted as a degree or certificate-seeking student in University College.
2. Be currently enrolled in courses totaling a minimum of 3 semester hours.
3. Demonstrate financial need based on the information supplied on this application.
4. Have a minimum 2.50 GPA.
5. Be a US citizen or permanent resident.

To Apply:

1. Submit to University College a completed Application for Tuition Assistance by the deadline.
2. Submit to University College a personal statement.
