# 2008-2009 Annual Assessment of University Learning Outcomes

### **Law School Assessment Report-Measures and Evidence**

## 1. Disciplinary Competence and/or Professional Proficiency

#### **Measures to Assess:**

The measures to assess include: bar examination; alumni surveys; externship feedback; required legal writing requirements including moot court brief and oral arguments; course exams, papers, in-class simulations and presentations.

### **Evidence of Student Learning:**

July 2008 Bar Pass Results; alumni survey instrument; learning objectives for externships were all submitted samples of evidence related to measures of student learning.

### 2. Critical Thinking Skills

### **Measures to Assess:**

The measures to assess include: bar examination; required legal writing requirements including moot court brief and oral arguments; course exams, papers, in-class simulations and presentations.

### **Evidence of Student Learning:**

July 2008 Bar Pass Results: we had 137 of our 2008 graduates taking the July 2008 bar exam (9 graduates did not take the bar exam). Students took the exam in 24 different states. We had 124 graduates pass the exam; 13 failed, resulting in a 90.51% pass rate for the class of 2008. For Nebraska, we had 88% (37/42) pass rate for first time takers, and for lowa, we had 100% (23/23) pass rate for first time exam takers.

#### **Measures to Assess:**

Measures to assess included the following: Senior surveys; alumni surveys; Law School Survey of Student Engagement.

#### **Evidence of Student Learning:**

#### **Measures to Assess:**

The measures to assess include the following: bar examination; alumni surveys; externship feedback; required legal writing requirements including moot court brief and oral arguments; course exams, papers, in-class simulations and presentations.

July 2008 Bar Pass Results; alumni survey instrument; learning objectives for externships were all submitted samples of evidence related to measures of student learning.
