- a. Peer Review
 - i. Still many programs with 1 review remaining.

 - iii. A preliminary Peer Review report scheduled for the May meeting.

b. Professional Development

- i. "Building a Culture of Assessment that Works for Your Needs" assessment workshop will be held Wednesday, April 26; 11:30-1; Skutt SC 105.
 - 1. Initial survey was sent to 77 Creighton faculty/staff, who were identified by UAC members, in March seeking feedback on college/school/area assessment needs.
 - a. Feedback from survey will identify how program will be structured, with focus on guiding questions.
 - 2. Invitation to attend the program will be sent to the 77 individuals on Tuesday, April 18.
 - 3. UAC members were asked to: 1) volunteer as a table facilitator as the program and 2) identify faculty who may choose to engage in this assessment training efforts.
- ii. Fall Assessment Symposium; Friday, Nov. 3; Skutt Auditorium
 - 1. Call for posters is in the draft stage. It is to be completed and ready for distribution at the professional development program on April 26.
 - 2. The UAC agreed that pursuing the option of identifying local experts/speakers for the Fall Symposium is an idea for the subcommittee to move forward with potential topics/theme. In addition, potential themes/topic, maybe found in the HLC final report, the Professional Development program held in April, and/or peer review assessment report results.

c. Academic Program Review

 - 1. Reviews completed: Medical Anthropology, Social Work, Microbiology and Immunology, Clinical and Translational Sciences, Clinical Anatomy.
 - 2. Reviews underway: MD, American Studies.
 - 3. Late Spring: Chemistry, English, Biomedical Sciences, Pharmacology.

- e. Policy, Strategy, and HLC updates
 - i. HLC Evaluation Team of Creighton University site visit was well received. Fr. Hendrickson should receive a final report from the HLC liaison by August.
