- c. Co-Curricular Assessment Workshop(s)

The committee received a copy of the Call for Nominations and the Instructions on how to submit an application. The online application process is easy to navigate through with text boxes to assist in entering one’s nomination information.

- a. Academic Program Review

  - i. The committee is working on several projects and will report on them next month.
- c. Peer Review
  - i. The rubric has been updated to include learning outcomes being mapped to school/college outcomes.
  - ii. The customer report from the previous year maybe unlocked and accessed as a resource for this year review. The findings report cannot be unlocked and used for the 2013-2014 reports.
  - iii. On December 10<sup>th</sup>, the peer review committee will meet to discuss processes and provide an orientation for those new to the peer review process.
