

## Feed Back for July 2015

1. **Question:** As chair of SAC I received many emails and phone calls regarding the June 25 situation on campus where US Marshalls and Omaha Police arrested a person in Rigge. It was a very tense and scary time for staff, faculty, students, and visitors. There were a lot of concerns regarding why CU Alert was not used.

**Answer:** *The situation yesterday evolved rather quickly. No communication was initiated by the police to alert Public Safety to their presence so it did take time for us to find out exactly what was transpiring. Then the subject's location changed from 27th and Burt to the Criss Complex and finally to Rigge Science. A decision was made to initiate a CU Alert, but as the Public Safety Dispatcher was customizing the content message and I was composing the CU Official email to communicate additional information about the situation, Public Safety was informed that the suspect had been arrested. Consequently, only the CU Official was sent out notifying the community that this individual was in custody.*

*Understandably the large police presence was unnerving. We will continue to seek improvements in our communications and look for ways to minimize the disruption, anxiety and chaos associated with events such as these. We intend to review this recent event with our Crisis Management Team and see how our processes might be improved. Rick McAuliffe, Public Safety Director*

2. **Question:** I understand the need to conserve energy during these high summer temperatures. However, the elevator has been shut off in Creighton Hall. Is this a coincidence or due to the university's energy conservation rules? So far, the elevator has not been fixed / turned back on. I am very concerned because we have an employee in our office who just returned after knee surgery, uses a cane, and cannot take the stairs. There are also pregnant women and handicapped individuals in this building.

**Answer:** *The elevator motor had been leaking hydraulic fluid for a period of time. The elevator company called Facilities to schedule the repair. In the middle of what was to be a quick repair the elevator company discovered that an additional part was needed that was not readily available. The part needed to be overnighted to town. The next day the elevator was fixed. Miscommunication was found on both sides. It has now been put into place that anytime an elevator needs to be shut down for any period of time the elevator company will contact Lou Marcuccio and he will first inquire as to the building's schedule and then schedule the work and inform the building occupants. **Answer :***The bookstore receives merchandise in a variety of colors with Creighton and/or the University logo included. The shirt in question has been carried in pink, green, yellow, orange, red and blue as part of a summer color palette. The font used on the shirts is approved by licensing and is also used on many other items. The shirt is not considered a game-day shirt, and items that are specific to certain sports are carried in blue, white and/or gray.
