### **SUMMER SCHOOL 2022**

Online registration for the 2022 Summer Sessions will begin on Thursday, March 24, 2022 at 4:00 pm and end on May 8, 2022. Your registration PIN and Web Registration Instructions will be sent to you in a separate email. No changes to registration will be allowed between May 9 and May 15. Your individual tuition, financial aid and any scholarships will be calculated during this time period. Any changes to your schedule made after May 8, which result in a net change in total credit hours, will cause delays and changes to tuition, financial aid and scholarships.

If you are interested in registering for an externship, please contact Professor Uchimiya as soon as possible. Please note that some externships require an extensive personal background check.

There will be two courses offered through the Germany Summer Abroad Program: International Criminal Law, and From Nuremberg to The Hague: The Impact and Legacy of the Holocaust on the Law. Information about the summer abroad program can be found on the Law School website under Academics.

Attached is a list of the Summer 2022 course offerings for Terms 1 and 2, followed by the course descriptions and a class schedule. If you have questions about specific courses, please contact the professor teaching that course. The Summer 2022 Final Exam Schedule and the 2021-2022 Academic Calendar are also attached.

### **ADDITIONAL INFORMATION**

1. **Term 1** will begin on May 16, 2022. The last day of classes will be June 24 and exams will be June 27-28. There will be no classes on Monday, May 30 (Memorial Day). **Term 2** will begin on July 5. The last day of classes will be August 5. Exams will be August 8-9. Students may enroll in both summer sessions.
2. Days, times, and dates of class meetings vary. Please note the varying starting and ending dates for each.
3. Tuition is \$1425 per credit hour, plus university and technology fees. Cost for the Germany Summer Abroad Program can be found on the website at: <https://law.creighton.edu/academics/study-abroad-programs/nuremberg-summer-program/fees-policies-and-housing>. Students enrolled in the Nuremberg Moot Court Competition will incur an additional tuition fee for the credit hours that will be earned for participation in the competition.

Financial aid for summer school is available. In order to be considered for financial aid for the 2022 summer term, students enrolling in at least 3 credit hours must complete a 2022/2023 Free Application for Federal Student Aid (FAFSA). In addition to the FAFSA, students will need to complete a Creighton University Summer Aid Application. 4. If a student becomes academically ineligible after Spring 2022 semester grades are in, the student's Summer School registration will be cancelled and tuition will be refunded.
