# Awards, Honors and Scholarships

**The Creighton University Department of Accounting Godfathers Accounting Scholarship** – An annual scholarship given to accounting majors who are pursuing an accounting career.

**Membership in Alpha Kappa Psi, Delta Pi Chapter** – A professional business fraternity.

**Membership in Alpha Sigma Nu** – A National Jesuit Honor Society for scholarship, loyalty and service.

**Arthur Andersen and Co. Endowed Scholarship** – This endowed scholarship was established from gifts received from employees of Arthur Andersen and Company. It is awarded to a senior accounting major who has evidenced a professional level of technical ability, self-confidence, strong interpersonal and communications skills, leadership abilities, and a sincere interest in the public accounting field.

**John P. Begley Endowed Chair in Accounting Scholarship** – An annual scholarship in memory of Dr. Begley to accounting majors pursuing a career in accounting.

**Membership in Beta Alpha Psi** – A national accounting, finance and business analytics honorary fraternity for excellence in scholarship.

**Membership in Beta Gamma Sigma** – A national honor society; membership is granted to seniors who rank in the upper tenth percentile of their graduating class and to juniors who rank in the highest seven percentiles in the last semester of their junior year.

**Rowley ‘Pat’ Irwin Blakeney Scholarship** – Awarded to academically qualified freshmen students in the Heider College of Business who graduated with honors from their high school class.

**Bradley, Elmer L. & Margaret M. Scholarship** – This endowed scholarship was established in 1995 by Mrs. Margaret Bradley and her late husband Elmer. Elmer was a graduate of the CU College of Business Administration (1943). Funds from this scholarship shall be used to assist students with high academic standing to enroll in Heider College of Business. Preference will be given to graduates of Nebraska high schools and is renewable by meeting normal academic progression standards and a 2.0 cumulative GPA.

**Business Research Fellows** – An elite group of students that are encouraged to think critically on issues facing the world in which we live.

**Fr. Neil Cahill, SJ, Scholarship** – This endowed scholarship was established in 1994 by longtime faculty member the Rev. Neil Cahill, SJ. Candidates must be of high academic standing, and students from South Dakota will receive preference. Fr. Cahill died in 2001. A 2.0 is required for renewal.

**Christian Ethics Scholarship** – Awarded to a junior or senior Heider College of Business student who shows a commitment to the Catholic mission of Creighton University and is a witness to Christian ethics in the field of business.

**Heider College of Business Scholarship** – This scholarship recognizes students for exceptional service accomplishments and leadership potential.

**Dean’s Fellows** – The first honors program in the Heider College of Business. This program is designed to allow high-achieving students the opportunity to transform into business leaders focused on integrity before profits. These seniors were selected their freshmen year based on their exceptional leadership skills and commitment to service.

**Dean’s Honor Roll for Social Responsibility** – Awarded to undergraduate students who, in one semester, perform at least 25 hours of community service, report confirmed hours to the dean’s office, and submit a personal reflection.

**Edward C. Creighton Scholarship for Business and Social Responsibility** – Awarded to juniors and seniors in the Heider College of Business who are members of the Dean’s Honor Roll for Social Responsibility and who exhibit exceptional potential as future business and community leaders.

**Ernst & Young Accounting Scholarship** – An annual award funded by Creighton Accounting and other alumni and the EY Foundation to accounting majors pursuing a career in accounting.

**Edward W. & Nancy E. Fitzgerald Scholarship** – This endowed scholarship was established in 2006 by Mr. and Mrs. Edward Fitzgerald to assist accounting students enrolled in the College of Business who have high academic credentials. It may be renewed for future years by maintaining at least a 2.5 cumulative GPA.

**Creighton Business Symposium Team** – This team is composed of Anna Tyler Waite Leadership students who take part in a day-long event featuring business speakers and panel discussions on the important challenges facing business professionals today. It is the largest student conference in the United States.

**Frederick J. de la Vega Scholarship** – This endowed scholarship was established in 1994 from a bequest from the late Dr. Frederick de la Vega, a Creighton alumnus. Students in the three undergraduate colleges are eligible for these highly competitive awards. Academic achievement is the main criteria upon which selections are based. Between equally eligible applicants, a preference is given to students of color.

**Outstanding Entrepreneurship Graduate** – Awarded to an exemplary graduating entrepreneurship major who shows high potential in the field.

**Robert L. Gradoville Memorial Scholarship** – This endowed scholarship helps to support a student-athlete on the baseball team who demonstrates financial need and a competitive spirit both on and off the playing field. Past participants are also eligible for consideration.

**Adolph Hallas Scholarship** – This endowed scholarship was established in 1991 from a bequest made by the late Adolph J. Hallas, graduate of the College of Business in 1925. The endowed fund supports up to four scholarships each year to students in the College of Business.

**William R. Heaston Midwest Insulation Contractors Association Accounting Scholarship** – An endowed scholarship established in memory of Emeritus Professor of Accounting William R. Heaston, for accounting majors pursuing a career in accounting.

**Heaston Memorial Scholarship** – Awarded annually to finance majors in the Heider College of Business who demonstrate high academic promise and extracurricular leadership in the College and University.

**Heider College of Business Ethics and Social Responsibility Scholarship** – Awarded to students for exceptional service accomplishments and leadership potential.

**The Creighton University Heider Business Senate** – A liaison between the student body and the administration of the Heider College of Business. The Senate promotes the mission and values of the Heider College of Business through various projects.

**James and Helen Hughes Herbert Scholarship** – An endowed scholarship for Heider College of Business students, based on grade point average, involvement in extra-curricular activities and work history, with preference given to those pursuing an accounting career.

**Outstanding Human Resources Graduate Award** – This award recognizes a graduating senior within the human resources major whose academic performance, professionalism, leadership and service to the greater community best reflects the ideals of a Jesuit, business education.

**Christina Hixson Lied Foundation Trust Scholarship** – Recognizing students with a potential for success in the business world.

**James & Jean Kisgen Scholarship** – Established in 2007 by Mr. James Kisgen CoBA '64, this scholarship recognizes a junior accounting major with at least a 3.0 grade average. Preference will be given to students from Carroll-Kuemper High School in Carroll, IA. It is automatically renewed for the senior year by maintaining the grade average shown and normal progression toward graduation.

**KPMG-LLP Foundation Endowed Accounting Scholarship** – Awarded to a junior or senior Heider College of Business student who shows a commitment to the Catholic mission of Creighton University and is a witness to Christian ethics in the field of business.

**T. Leslie Kizer Scholarship** – A renewable scholarship awarded to a Heider College of Business student based on academics and extracurricular activities.

**Lutz Accounting Scholarship** – Funded by the partners of Lutz, this annual award is made to accounting majors who are pursuing a career in accounting.

**John L. & Carol V. Maginn Scholarship** – An endowed scholarship established in 1995 by Mr. and Mrs. John Maginn. It is designed to assist students enrolled in Creighton's Heider College of Business who are academically qualified. Preference is given to women and students of color.

**David and Kathleen McKernan Scholarship** – An endowed scholarship established in 2019 for senior accounting majors with demonstrated need and high GPAs, preferably pursuing a double major in finance.

**Nebraska Society of Certified Public Accountants** – An annual award made by the Foundation of the NSCPAs to accounting majors pursuing education to qualify to sit for the CPA exam.

**Orr Accountancy Scholarship** – An endowed scholarship established by Jon Orr in 2018 to assist accounting majors who demonstrate need, maintain high grades and provide community service.

**Outstanding Marketing Graduate** – Awarded to an exemplary graduating marketing major who shows high potential in the field.

**Public Companies Accounting Oversight Board** – A national scholarship award made annually by PCAOB administrators to students majoring in accounting at select schools to recognize high academic achievement and promise for ethical practice of accounting.

**Thomas J. Purcell Deloitte Foundation Scholarship** – An endowed award funded by students, classmates, colleagues and friends to honor Dr. Purcell's significant contributions to the accounting profession and the community. Awarded to accounting majors pursuing a career in accounting.

**2023 Murphy Cup Competition Team** – A regional marketing strategy competition where students present a solution to a real-world business scenario to industry experts.

**Membership in Omicron Delta Epsilon** – An international honor society in economics that serves to recognize scholastic achievement by honoring students with outstanding achievements in the field.

**Phi Beta Kappa** – The nation's oldest academic honors society that recognizes exceptional breadth and depth of knowledge in the liberal arts and sciences.

**RSM Accounting Scholarship** – An annual award funded by Creighton Accounting alumni and the RSM Foundation to accounting majors pursuing a career in accounting.

**Scholarship for Women in Business** – This scholarship was established in 1999 by Ms. Comerford to assist female students enrolled in the Heider College of Business who maintain at least a “B” average. Students from Iowa are given first preference, then students from Nebraska.

**Scott Fellows** – Awarded by the Suzanne and Walter Scott Foundation to academically gifted students enrolled in the Heider College of Business, with preference given to students from states other than Nebraska.

**Scott Scholars Endowed Scholarship** – An endowed scholarship awarded to students in the Heider College of Business who represent the pinnacle of academic excellence, based on high school grades and national entrance exams.

**Stephen Summers Memorial Scholarship** – This endowment recognizes a 3rd/4th year Heider College of Business student from the Kansas City metropolitan area who has at least a 3.0 grade point average. Preference is given to students in the entrepreneurship program, interning in the Halo Institute or finally to any undergraduate Heider College of Business student.

**Union Pacific Foundation Scholarship** – Awarded to a Heider College of Business student who shows outstanding potential for academic excellence in their chosen business field.

**Anna Tyler Waite Leadership Scholars Certificate** – Awarded to students who participate in the Anna Tyler Waite Leadership Program and complete a series of extra-curricular activities exploring the philosophies and actions of leaders to develop values and skills needed to lead effectively in a socially responsible environment.

**Anna Tyler Waite Leadership Scholarship** – Awarded to a student in the leadership scholars program based on the scope and significance of their leadership efforts.

**Floyd E. and Bernice C. Walsh Scholarship** – An endowed scholarship awarded to students in The Heider College of Business based on academic performance and extracurricular activities with preference given to accounting majors.

**Reverend William Weidner** – Awarded to accounting majors based on academic performance and campus and community activities.

**Union Pacific/Charles Billingsley Annual Accounting Scholarship** – A scholarship funded by the Department of Accounting in memory of Charlie Billingsley, former CFO, who had a lasting impact on accounting education.

**Patrick & Penny Zenner Scholarship** – This endowed scholarship was established in 1998 by Mr. and Mrs. Patrick Zenner. It is awarded to students enrolled in either the College of Arts and Sciences or the Heider College of Business. Candidates must show high academic credentials.
