This endowed scholarship was established in 1995 by Mr. and Mrs. Garner to assist students enrolled in the Heider College of Business who are of high academic ability.

Union Pacific Presidential Scholarship

Funded from a gift by the Union Pacific Foundation, this endowment supports the University's highest academic award. Preference will be given to eligible students enrolled in the College of Business.

Union Pacific/Charles Billingsley Annual Accounting Scholarship

Funded by Department of Accounting in memory of Charlie Billingsley, former CFO, who had a lasting impact on accounting education.

V.J. & Angela Skutt Scholarship

This endowed scholarship was established in 1989 by the late V.J. Skutt, former chairman of the board of Mutual of Omaha. This scholarship is given each year to two entering freshmen from South Dakota. Preference is given to pre-law and business administration students.

Valentino Family Memorial Scholarship

This endowed scholarship is awarded to students in the Creighton School of Law and Heider College of Business who are of high academic standing. Scholarships are awarded to business students majoring in Economics or Finance. Law students are selected by the Law School.

William Ellis Memorial Scholarship

The donors established this endowed scholarship to honor their husband and father who was a loyal supporter of the Creighton Baseball program. A member of the baseball team who is eligible to participate in intercollegiate athletics will be selected to receive this award.

William A. Fitzgerald Memorial Scholarship

This endowed scholarship was created to pay tribute to and to memorialize the service and dedication of William A. Fitzgerald, BSB'59. Awarded to students who graduated from an Omaha, Nebraska High School and are enrolled in the Heider College of Business.
