**MOONLIGHT AND VOLUNTEER POLICY
2022-2023**

PURPOSE

In compliance with the Council of Podiatric Medical Education and Common Program Requirements, it is the goal of Creighton University to outline the departmental policy on Moonlighting and Medical Volunteer Activities for residents in the Creighton University Podiatric Medicine and Surgery Residency with Reconstructive Rearfoot/Ankle Program (CU PMSR/RRA).

SCOPE

This policy applies to all podiatry residents under the sponsorship of Creighton University Podiatric Medicine and Surgery Residency with Reconstructive Rearfoot/Ankle Program (CU PMSR/RRA).

DEFINITIONS

Moonlighting: Moonlighting refers to a service performed by a resident in the capacity of an independent physician, completely outside the scope of his/her residency-training program.

Volunteering: An activity when a resident works in a medical professional capacity off duty for no compensation.

GENERAL POLICY

- **Moonlighting during podiatry residency training at Creighton University is not permitted.**
- **Moonlighting is not required by the program or Valleywise Health Medical Center.**
- **Volunteering is not required by the program or Valleywise Health Medical Center.**

In the event of any discrepancies between program policies and the GME policy, the GME policy shall govern.
