## **Special Circumstances Requests/Reviews Policy**

Creighton University, as allowed by law, considers life changes that occur after the completion of the FAFSA. Special circumstances are reviewed on a case-by-case basis, and the university is limited regarding the adjustments that can be made. The Financial Aid Office must have the results of a valid FAFSA prior to any review. If requested documentation is not attached or items are missing, the form may not be processed. As such, if clarification of your situation is necessary, we may request additional information or documentation beyond the requested items below. In most cases, Special Circumstances Requests/Reviews will not be processed until parents have completed their 2022 federal taxes and are able to obtain their 2022 federal tax return transcript or 2022 federal tax return and applicable schedules.

Please note that we will not consider:

- a reduction in overtime pay, commission, bonuses, or one-time winnings.
- projected/estimated income from those who are self-employed (due to lack of official income documents that are able to be provided such as paystubs).
- Insurance Premiums or deductibles.
